Dear Mr. Peterson:

The subject facility has a hazardous waste long-term care license and long-term care and corrective action responsibilities regarding but not limited to closed surface impoundments. The Wisconsin Department of Natural Resources is considering licensing actions for the subject facility under ch. NR 670, Wis. Adm. Code. In most cases, we name both the owner and operator as licensees when a license is renewed or reissued. Our records indicate that currently the property owner is TRP Properties, LLC. Beazer East, Inc. has informed us that, in general, it is responsible for certain environmental conditions or circumstances at the facility occurring or existing prior to December 29, 1988, and Koppers, Inc maintains liability for certain environmental issues at the Site occurring after that date.

We request that you confirm that you are the proper point of contact for property owner and that the contact information in the address section of this letter is correct. We also request that you describe the responsibilities of other parties regarding the long-term care and corrective action requirements of ch. 291, Wis. Stats and chs. NR 660 through 679, Wis. Adm. Code, so that we can accurately identify any the operators(s) as licensees. We request this information within 14 days of the date of this letter. The authority for this request is in s. 291.91, Wis. Stats.

Prior to issuance, you (and other any other licensees) will be provided a draft version of the license for your review and comment. All applicable requirements of chs. 289 and 291, Wis, Stat., and chs. NR 600 through 679, Wis. Adm. Code will continue to be effective irrespective of the license.

Note that s. NR 664.0012(3), Wis. Adm. Code, requires the owner or operator to notify a new owner or operator in writing of certain hazardous waste requirements. You may want to consult with the former owner for this sort of background information.
