I found the record drawing showing where the old Sanitary Lateral was capped off. See the attached drawing.

Does this information change the need to access the 3 additional manholes or not.

In our call earlier today, you stated that you also want to test the following 3 manholes:

San. M.H. #7-143, 7-147 & 7-149 (S. 26th & Marshall St.)

We also had another discussion about traffic control.

My thought is that the City would use a truck that has an arrow board on it.

We would probably also put out advance warning signs on all 3-4 streets ahead of the work.

Our best guess right now for say 3 hrs. of the truck and 1 man would be about \$500 plus or minus.

You were hoping that we could just bill this to the contractor, SCS, but you were still needing to confirm that with Rob.

Hi Sarah,

Of course I found the map as soon as I got off the phone. Thank you anyway.

I have printed and scanned a similar map, but with the aerial photo attached.

Based on our conversation this afternoon, you informed me that the vapor intrusion system has been installed at the Golden Flame last week, but there is still some work to do to finish it completely. You also stated that the DNR is still trying to determine what do to with the impacted storm water from the Flame's sump pump.

The next step is that the DNR wants to test for vapor intrusion of the sanitary sewer in this area.

It is my understanding that you will want access to Sanitary Manhole #'s 7-139, 7-142, & 7-146. I have circled them in red on the attached map.

You indicated that SCS is being hired to perform the work for the DNR. The DNR is hoping that they will be able to do the work in the next 4-6 weeks and before the cold winter weather settles in.

You said that it takes about 30 minutes at each manhole to do the testing, so that all work should be completed within about a 2 hour period.

After we discussed this, it appears that the best and easiest option is to have the City set up the necessary traffic control.

I need you to determine what lane closures would be needed and what the appropriate traffic control would be for this very busy intersection.
