Sarah,

After reviewing the email chain and the attached figures, and understanding that your current scope for contracting includes sampling three manholes, I agree with your recommendation to

at least sample 7-147, 7-146 and 7-142. If the scope is able to be expanded prior to this mobilization, I recommend also including (in order of preference) the manhole south of 7-142 on S. 26th St. (not shown on map) based on the unknown location of the former lateral from the former dry cleaner, 7-139 and 7-143. As with all investigations, the vapor investigation may need to expand dependent upon initial results.

I look forward to seeing the results and discussing this case further within our Dry Cleaner and Vapor Intrusion Team. The next meetings are Skype calls on 10/22 and 11/26 and an in-person meeting on 12/17.

We are not sure where the lateral went, the city did not have any information prior to the road reconstruction in 2001, however we do know that the properties along south 26th street did not have any Vapor Risk Screening Level exceedances. I was thinking that 7-147 was potentially an up-stream location, 7-146 was the closest to the source, and 7-142 was the nearest downstream location. We could look at 7-139 and a manhole south on 26th street away from the source area but had originally scoped to look at only 3 manholes.

The Sanitary, Water and Storm sewers were all replaced as part of the roadway reconstruction in 2001 the dry cleaner closed at some time during the 1970s and the building then contained a family restaurant until the late 1990s. I am unsure if the sewer has been video logged since the construction work.

Hi Sarah,

Of course I found the map as soon as I got off the phone. Thank you anyway.

I have printed and scanned a similar map, but with the aerial photo attached.

Based on our conversation this afternoon, you informed me that the vapor intrusion system has been installed at the Golden Flame last week, but there is still some work to do to finish it completely. You also stated that the DNR is still trying to determine what do to with the impacted storm water from the Flame's sump pump.

The next step is that the DNR wants to test for vapor intrusion of the sanitary sewer in this area.

It is my understanding that you will want access to Sanitary Manhole #'s 7-139, 7-142, & 7-146. I have circled them in red on the attached map.

You indicated that SCS is being hired to perform the work for the DNR. The DNR is hoping that they will be able to do the work in the next 4-6 weeks and before the cold winter weather settles in.

You said that it takes about 30 minutes at each manhole to do the testing, so that all work should be completed within about a 2 hour period.

After we discussed this, it appears that the best and easiest option is to have the City set up the necessary traffic control.
