GHD Services Inc. (GHD) has prepared this monthly status update for the period of April 2019 for the Penta Wood Products Superfund Site (Site). The project budget and costs are summarized in the following Table 1. All problems, resolutions, and/or recommended solutions with an assessment of data collected during this period will be provided in the next Semiannual Report – January through June 2019. The following is a brief summary of the work completed.

Phase 06-Task 01 Site safety plan preparation

- The Site-Specific Health and Safety Plan was finalized.

- Mowing and fire extinguisher subcontractors were coordinated for April 2019 Site work.
- The annual fire extinguisher inspection was conducted on April 25, 2019.
