GHD Services Inc. (GHD) has prepared this monthly status update for the period of July 2022 for the Penta Wood Products Superfund Site (Site). The project budget and costs are summarized in the following Table 1. All problems, resolutions, and/or recommended solutions with an assessment of data collected during this period will be provided in the Semiannual Report – January through June 2022. The following is a brief summary of the work completed.

1. Task 03.01 Site Safety Plan Preparation

- No work was performed for this task during this period.

2. Task 03.02 Housekeeping and Grounds Keeping

- This invoice includes subcontractor (Austin Lake Landscaping) costs for mowing on June 7, 2022.

3. Task 03.03 Semiannual Groundwater/LNAPL Level Monitoring

- No work was performed for this task during this period.

4. Task 03.04 Semiannual Groundwater Well Sampling

- Hydrographs depicting historical pentachlorophenol concentrations, groundwater elevations, and LNAPL thicknesses were prepared.

5. Task 03.05 Semiannual Residential Well Sampling

- Residential wells RW2 and RW5 were re-sampled on June 20, 2022. Residential well RW1 was also sampled on June 20, 2022 since the well could not be sampled during the April 2022 event.
- The June 2022 residential well sample analytical data was evaluated.
- The June 2022 residential well sample results were issued to the property owners in letters dated July 11, 2022.
- This invoice includes laboratory (Eurofins) costs for the residential well sample analyses.

6. Task 03.06 Semiannual Reporting

- A preliminary draft Semiannual Report – January through June 2022 was prepared and reviewed.

7. Task 03.07 Monthly Reporting

- Periodic project updates were provided to WDNR.
- The project budget was updated.
- The Monthly Status Update – June 2022 was submitted on July 13, 2022.

8. Task 03.08 Regulatory Communications

- No work was performed for this task during this period.

9. Task 03.09 Additional work

- No work was performed for this task during this period.
