## 1. Phase 04-Task 01 Remedial Action Oversight

- Access agreements were prepared and sent to adjacent property owners on July 11, 2022 for conducting portions of the remedial action. Follow-up calls were made to the property owners to coordinate site meetings and remedial action discussions.
- A conference call was held between USEPA, WDNR, and GHD to discuss the status of the remedial action including access agreements, bidding document preparation, scope of work for additional site characterization on July 22, 2022.
- The Remedial Action Bid Documents were compiled and posted on the State of Wisconsin eSupplier website on August 1, 2022.
- A preliminary draft Construction Quality Assurance Project Plan (CQAPP) was prepared.
- The Monthly Status Update June 2022 was submitted on July 13, 2022.
- The project budget was updated.


