Monthly Status Update – Remedial Action Oversight, May 2023 Penta Wood Products Superfund Site Siren, Wisconsin WDNR BRRTS Activity #02-07-000532

GHD Services Inc. (GHD) has prepared this monthly status update for the period of May 2023 for the Penta Wood Products Superfund Site (Site) and remedial action oversight (wetland excavation and surface debris mitigation). The project budget and costs are summarized in the following Table 1. The following is a brief summary of the work completed.

1. Task 04.01 Remedial Action Oversight

- Progress meetings were held between USEPA, WDNR, RLW and GHD to discuss the remedial action on May 2, 9, 16, 23, and 30, 2023, and progress meeting minutes were issued on May 4, 12, and 19, 2023 and June 5 and June 5, respectively.
- Remedial action construction activities were performed in May 2023 following removal of the State of Wisconsin seasonal road restrictions. Primary activities included:
 - Equipment re-mobilization to the Site
 - Routine stormwater inspections
 - Additional clearing and grubbing
 - Silt fence removal surrounding the wetland excavation
 - Additional silt fence installation
 - Mixing sand with excavated wetland material for stabilization prior to placement, compaction, and grading
- Onsite remedial action oversight was performed and documented in May 2023.
- Preparing a revised grading plan for placement of additional excavated wetland material
- Construction Bulletin No. 6 was issued for imported drainage sand testing and analysis May 19, 2023.
- Submittals provided by Rock Leaf Water Environmental, LLC (RLW) were reviewed.
- The RLW application for payment covering work in March 2023 was reviewed and a recommendation for payment was provided to WDNR on April 20, 2023.
