GHD Services Inc. (GHD) has prepared this monthly status update for the period of June 2023 for the Penta Wood Products Superfund Site (Site). The project budget and costs are summarized in the following Table 1. All problems, resolutions, and/or recommended solutions with an assessment of data collected during this period will be provided in the Semiannual Report – January through June 2023. The following is a brief summary of the work completed.

1. Task 03.01 Site Safety Plan Preparation

- No work was performed for this task during this period.

2. Task 03.02 Housekeeping and Grounds Keeping

- A sample was collected from waste materials generated during groundwater monitoring and sampling activities. Waste materials are stored in a drum at the Site and consist of PPE and supplies that came in contact with LNAPL. The sample was submitted for laboratory analyses to characterize the waste, and the analytical data was evaluated to develop a waste disposal profile.
- This invoice includes laboratory costs (Eurofins Environment Testing Laboratory) for the waste characterization sample analyses.

3. Task 03.03 Semiannual Groundwater/LNAPL Level Monitoring

- No work was performed for this task during this period.

4. Task 03.04 Semiannual Groundwater Well Sampling

- The April 2023 semiannual groundwater well sampling data was reviewed.
- This invoice includes rental vehicle costs incurred during the April 2023 semiannual groundwater well sampling event.
- This invoice includes shipping costs (FedEx) for delivering groundwater samples to the laboratory.
- This invoice includes laboratory costs (Eurofins Environment Testing Laboratory) for groundwater well sample analyses.

5. Task 03.05 Semiannual Residential Well Sampling

- The April 2023 semiannual residential well sampling result letters were issued to the property owners on June 9, 2023.
- The April 2023 semiannual residential well sampling analytical data validation memorandum was prepared.
- This invoice includes laboratory costs (Eurofins Environment Testing Laboratory) for residential well sample analyses.

6. Task 03.06 Semiannual Reporting

- Portions of the Semiannual Report – January through June 2023 were prepared.

7. Task 03.07 Monthly Reporting

- Periodic project updates were provided to WDNR.
- The project budget was updated.
- The Monthly Status Update – May 2023 was submitted on June 9, 2023.

8. Task 03.08 Regulatory Communications

- No work was performed for this task during this period.

9. Task 03.09 Additional work

- GHD met REI Engineering at the Site on May 31, 2023 to show the Site layout and features. GHD provided a verbal description of current and ongoing Site remedial actions along with a general Site history.
- This invoice includes GHD staff personal vehicle mileage.
