GHD Services Inc. (GHD) has prepared this monthly status update for the period of July 2023 for the Penta Wood Products Superfund Site (Site). 1. Task 03.01 Site Safety Plan Preparation

4. Task 03.04 Semiannual Groundwater Well Sampling
