On July 25, 2016, the Wisconsin Department of Natural Resources (department) received a Request for No Further Action at the Schindler Construction Company (Former) Report with the applicable fee. The department has reviewed the document and concurs that the environment has been restored to the extent practicable as provided in ch. NR 708.09, Wis. Adm. Code. The immediate action in response to a discharge has been completed and the Department of Natural Resources is requiring no further action at this time.

Excavation and initial investigation of soil impacted by a 1993 diesel spill from the fuel tank of a truck was completed by Superior Services Inc. (Superior) in 1994. The work completed by Superior is believed to have removed a majority of the affected soil; however, a full investigation of degree and extent was deemed necessary by the department. General Engineering Company (GEC) was retained by Mr. Thomas Lemke, Jr. in 2016 to complete the required site investigation. On June 29, 2016 GEC advanced six Geoprobe borings in the presumed area of the former spill, three of which were converted to temporary monitoring wells. Soil and groundwater samples submitted for laboratory analysis either did not contain detectable concentrations of petroleum volatile organic compounds (PVOCs) or naphthalene, or did not contain them at levels in exceedance of NR 720 residual contamination levels (RCLs). Based on these site investigation results submitted by GEC, the department believes that the degree and extent of residual contamination associated with the 1993 diesel spill has been adequately defined.

Low-level contamination remains in the soil at GP-2, the location of which is shown on the attached map, Geoprobe & Temporary Monitoring Well Location, Figure 3, June, 2016. The concentrations of naphthalene and 1,3,5-trimethylbenzene detected in the soil at this location do not require further action at this time, but this soil may require management as a solid waste if it is excavated in the future. The property owner or right-of-way holder at the time of excavation must determine whether the material is considered solid or hazardous waste and ensure that any storage, treatment or disposal

is in compliance with applicable standards and rules. Contaminated soil may be managed in accordance with ch. NR 718, Wis. Adm. Code, with prior DNR approval.

The July 19, 2016 Request for No Further Action submitted by GEC fulfills the requirement to fully investigate and remediate the site and therefore the Affidavit of Contamination placed on the deed is no longer applicable.

Attached is a Deed Notice ("Notice"), drafted by the Department that rescinds the Affidavit previously filed to the Property on September 8, 2000, document number 1105590. The Notice will need to be signed by you, as the property owner, in front of a notary. You will then need to file the Notice with the Winnebago County Register of Deeds office in Winnebago, Wisconsin, and pay the fee to file the Notice. The Register of Deeds office will file the Notice and provide you with a copy clearly stating the date it was filed.


