On September 8, 2000, Department of Natural Resources (DNR) filed a Notice of Contamination (Affidavit) which was recorded as document number 1105590, with the Register of Deeds in Winnebago County with the intent to notify the public of contamination existing at 1310 Earl Street in Menasha, WI (Property). DNR, in accordance with Wis. Admin. Code chs. NR 700-799 and Wis. Stat. § 292.11(3), determined, at that time, all administrative and statutory obligations for the release of contamination had not been met and the Affidavit was filed. The Affidavit recorded under Wis. Admin. Code § NR 728.11, was to notify the public of the existence and potential liability of petroleum contamination associated with ownership of the Property.

Since that time, remedial actions have been taken to address the source of contamination and impacts to the environment. On September 1, 2016, pursuant to Wis. Admin. Code § NR 708.09, the contamination case on your Property was closed with No Further Action (NFA) required as residual soil contamination was below applicable standards and groundwater was not impacted. Code § NR 728.11(3), this letter is to provide you notice of this decision. The attached Deed Notice is being recorded for the purpose of notifying prospective purchasers and other interested persons that the previously filed Affidavit, recorded on September 8, 2000, as document number 1105590, has been satisfied and is no longer applicable to the Property.

Attached is a draft of the document DNR intends to file with your Property deed. DNR will file this Deed Notice as stated above on your Property after August 13, 2021.
