For site investigation costs a \$10,000 deductible is applied to costs claimed up to \$200,000 per section 292.65 (8)(e) Wis. Stats. Your eligible expenses from your first claim (DCP-017) came to \$8,713.50, added to the deductible from this claim \$1,286.50, total to the \$10,000 mandatory deductible per the same code reference stated earlier. This will mean that you now have \$44,691.87 worth of eligible expenses and you will not have a deductible for the next \$155,308.13 worth of eligible future claims.
