Dear Mr. Gruichichi:

Your proposed Change Order #1 is approved. You may proceed with the proposed work. The DNR received the proposal titled Redi-Quick Dry Cleaner: Amendment Injection Approval Request & Change Order #1 prepared by Shaw Environmental, Inc. and submitted on your behalf on May 26, 2010.

The proposed work includes injecting approximately 2,315 gallons of 10-20% Newman's Zone treatment chemistry into the 27 injection locations instead of an initial proposal of 34 injection points..

Cost approved for this submittal is \$24,066 (Twenty-four thousand and sixty-six dollars). The cost approved for this remedial action is \$82,052 (Eighty two thousand and fifty-two dollars). The total cost approved for remediation to date for this site is \$106,118 (One hundred six thousand, and one hundred eighteen dollars).

Please be aware that you are required to comply with all applicable statutes and administrative rules including the NR 700 series, Wisconsin Administrative Code, hazardous waste management and wastewater discharges.

Please be aware that this letter does not represent Department "certification" that any response actions taken at your property, such as site investigation, remedial action or case closure under the ch. NR 700 series, are "approved by the Department," as those terms are used in the "remediated property; purchaser liability" section of the hazardous substance discharge law, s. 292.11, Stats.

This approval does not guarantee the reimbursement of costs under the Dry Cleaner Environmental Response Program. Final determination regarding the eligibility of costs for reimbursement will be made at the time of claim review.
