Your Change Order #4 is approved. You may proceed with the proposed scope of work based on the submittal: "DERF Budget Request - Vapor Sampling, Pilot Test for Vapor Mitigation System, Soil Sampling and Groundwater Sampling, Change Order #4 (Revised)", Redi-Quick Dry Cleaner, 9508 West Greenfield Avenue, West Allis Wisconsin, dated May 4, 2018. The submittal was prepared by APTIM Environmental & Infrastructure, Inc. (APTIM).

Based on the information provided by APTIM, the scope of work approved in this Change Order #4 is summarized below:

- Task 1 Sub Slab Vapor Sampling
- Task 2 Vapor Mitigation System Pilot Test
- Task 3 Soil Sampling
- Task 4 Groundwater Sampling and Sampling Update Report
- Task 5 DERF Claims

Cost approved for this submittal is \$24,592.24 (twenty-four thousand, five hundred and ninety-two dollars and twenty-four cents). The cost approved for the remedial action was \$82,052.00 (eighty-two thousand and fifty-two dollars).

Additional cost approved to date are as follows:

- Change Order #1 \$24,066.00 (twenty-four thousand and sixty-six dollars).
- Change Order #2 \$32,921.47 (thirty-two thousand, nine hundred and twenty-one dollars and forty-seven cents).
- Change Order #3 \$8,713.00 (eight thousand, seven hundred and thirteen dollars).

The total cost approved for the remediation of this site to date is \$172,344.71(one hundred and seventy-two thousand, three hundred and forty-four dollars and seventy-one cents).
