This is to request a projected schedule for when your firm, acting for the Town of Grafton, will sample four private wells designated as potentially at risk should the contamination plume spread beyond the established Village Water Service Area.

This was discussed publicly as a prudent and responsible measure to assure protection of remaining private wells in the Township, and should be part of the Village's long term plan for investigation and remediation of the site.



Dear Mr. Hofland:

This is to request, in part with investigation and remediation of the Lime Kiln Park groundwater problem, annual sampling of four residential wells for Volatile Organic Chemicals. This preventive action was discussed at various public meetings as a necessary safeguard for citizens just outside the Health Advisory Area established by EPA and DNR. These properties are not scheduled for connection to Village water, but are potentially first affected if contamination spreads. Along with any monitoring wells constructed by your consultant, sampling these active residential wells provides tangible evidence of drinking water safety on the fringe of the problem area.

Sampling frequency and wells chosen can certainly be modified in the future based on results of the first two rounds and other data on groundwater flow as determined by your consultant's investigation. In the interest of public health during these critical first years of the investigation, I request that these few wells be diligently monitored.
