Dear Mr. Smith:

Thank you for providing the Wisconsin Department of Natural Resources (DNR) with multiple revisions to your September 2016 closure request /GIS package. The DNR has received the following revisions from your consultant, TRC, since the initial submittal:

- Closure addendum dated December 6, 2016, in response to the DNR's administrative review comments;
- Closure addendum dated January 20, 2017, in response to the DNR's Southeast Region Closure Committee comments;
- Closure addendum dated March 2, 2017, in response to the DNR's requests regarding the shallow groundwater plume map modification, and deep groundwater plume map, and cross section information;
- Closure addendum dated March 30, 2017, in response to the DNR's informational requests regarding the deep groundwater plume map information, additional cross section, and table additions.

Remaining Actions Needed

Monitoring Well Abandonment

The monitoring wells at the site must be properly abandoned in accordance with ch. NR 141, Wis. Adm. Code. Documentation of well abandonment for all wells must be submitted to John Feeney on Form 3300-005, found at <http://dnr.wi.gov/topic/groundwater/forms.html>.

Documentation

Submit all changes to the original closure request in one final, complete compact disk (you are reminded to submit the requested modified residual soil contaminant map with the indication of direct contact soil exceedances). When the required actions have been completed, submit the appropriate documentation within 60 days of the date of this letter, to verify their completion. At that point, your closure request can be approved and your case can be closed.

GIS Registry

Your site will be listed on the DNR Remediation and Redevelopment Program's GIS Registry, to provide public notice of remaining contamination and continuing obligations. The continuing obligations will be specified in the final closure approval. Information that was submitted with your closure request application will be included on the Bureau for Remediation and Redevelopment Tracking System (BRRTS on the Web), at
