Dear Mr. Grasset:

On January 15, 1993, the Department received Cook Composites and Polymers' (CCP) Semivolatile Investigation Report. This report was prepared as a part of the closure of the former hazardous waste incinerator. In addition, the Department received a letter on January 28, 1993 with additional information for the Semivolatile Investigation Report consisting of professional engineer and facility certifications.

Based on the Department's review, this report fulfills conditional approval item #2 of the Department's Conditional Closure Plan Modification Approval, dated September 14, 1992. This investigation did not find semivolatile contamination in the former incinerator area significantly above background semivolatile contaminant concentrations. Based on these results, conditional approval item #3 of the September 14, 1992 Conditional Closure Plan Modification Approval for additional closure measures is not necessary. CCP should proceed with the closure plan and reduce volatile organic chemical contamination in the former incinerator area to the closure goal for benzene, toluene, ethylbenzene and xylene compounds.

We would appreciate being informed when the pilot soil-vapor extraction system is ready for installation. We are interested in seeing its installation and operation.
