TRC completed the monthly gas probe monitoring at the Refuse Hideaway Landfill in Middleton, WI on April 1, 2021. Attached are the monitoring results. Pressure, methane, carbon dioxide, oxygen, and methane (% LEL) are measured during the monthly event.

There was water in G-5, which prevented measurement of the gases present in the probe. TRC will attempt to monitor this location again next month.

The next monthly gas probe monitoring event will take place in May 2021.
