Hello Everyone,

We note the result for new well P-117 showing Vinyl Chloride above the ES and a depressed DO.

As a result, we would appreciate reaching agreement on sampling certain downgradient private wells immediately. We're looking at the locations to the west and southwest of P-117. Based on aerial photos, there appear to be at least 3 private wells – two along CTH PP to the north of the bike path and one to the southwest of the well to the north of STH 49. Please contact Rick Joslin and I to discuss this as soon as possible.

We would also appreciate reaching agreement now to provide the planned April sampling results for just this well as soon as the lab results are available, rather than waiting until the full quarterly report is prepared and submitted, which would be several weeks later. Please let us know what you believe would be the earliest date the results could be submitted to the agencies.

Thank you for your attention to this.

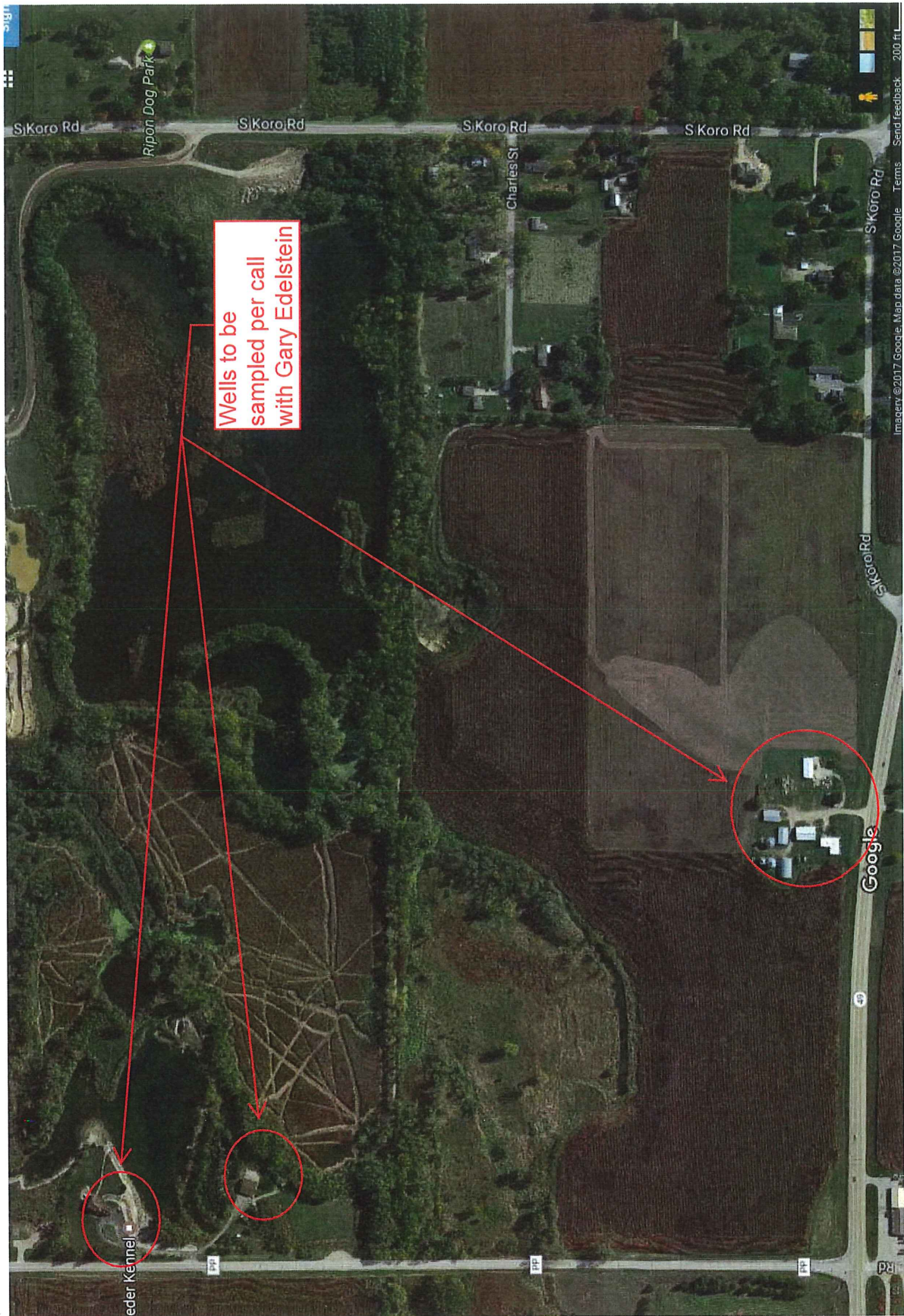
