Dear Mr. Stanley and Mr. Charles Skrzypek:

The Wisconsin Department of Natural Resources (WDNR) was notified on October 6, 1995 that petroleum contamination was discovered at the above-referenced location. In a letter October 18, 1998 the Department informed you of your legal responsibilities to address the situation. Because you did not respond to that letter, you were sent another letter on April 1, 1998, asking you to notify us of your intentions regarding cleanup at this site. The Department has yet to receive any information describing investigation or remediation at this site. Your letter of April 19, 1998 does not fulfill this requirement. A certified Notice of Noncompliance was sent January 4, 1999 and was not claimed.

If cleanup activities have not been implemented, you must hire an environmental consultant by March 22, 1999, and have them submit written verification to this office that they have been hired to address this problem. By April 5, 1999, your consultant must submit a site investigation work plan.

If investigation and/or remediation has occurred, you must provide the Department with documentation describing these activities by March 22, 1999.

If this situation is not adequately addressed this case will be referred for enforcement action and a Notice of Violation issued.

All submittals must be identified with the WDNR BRR CASE ID number; unless otherwise requested, please send only one copy of all submittals.

The Department will enforce Wisconsin's cleanup laws and we will cooperate with you in any way that we can within the limits of our own responsibilities. However, if you fail to comply with the requirements listed in this letter, the next step in the process will likely be a Notice of Violation and enforcement conference. Your cooperation in this matter would be appreciated.
