I reviewed the results with the Peer Committee and DNR will be issuing a No Action Required determination for this site as well as nullifying the deed restriction in place. Is the County okay with an email notification of the No Action Required once I have processed it, or would you like a formal letter? The formal letter will require a \$700 General Liability Clarification fee.

Additional, DNR noticed on Table 1 from the Phase II Report that the data units are incorrect. The units are listed as mg/kg but should be ug/kg as listed in the lab data sheets; once the units are corrected this will also change the number of standard exceedances. DNR requests your consultant update Table 1 and resubmit it.
