On August 12, 1998, Greg Konicek from KEY Engineering phoned me on your behalf. He informed me that you have retained the services of KEY to investigate the contamination at 349 Main Street in Reedsburg. While the Department is pleased you have taken action to proceed with the investigation, the Department still intends to hold the conference with you on August 26,1998.

Mr. Konisek indicated that you might not be able to attend at this scheduled time. If this is the case, you must notify the Department at least 48 hours prior to the meeting and reschedule. If you fail to notify the Department that you are unavailable at the scheduled time and fail to attend, the Department will recommend further enforcement actions be initiated. As communicated in my July 27, 1998 letter to you, those actions could include a direct referral to the Attorney General's Office seeking a court ordered schedule for completion of the necessary work. You should also be advised that referrals to the Attorney General's Office for prosecution typically result in forfeitures for these violations.
