Greg phoned to inform the Department that KEY Environmental has been contracted to investigate the contamination at the Reedsburg Cleaners sites by Wayne Butz. GC intends to come in and review the Reedsburg Cleaners sites and the Spellman Monument site, located across the street from this site, which is on hold temporarily until an investigation is performed at the Reedsburg Cleaners sites OR it is determined that an investigation will not be performed within a reasonable amout of time due to resistance by WB.

GC also inquired about the letter sent to WB on July 27, 1998, informing WB of an enforcement conference to be held. I informed GC that we intend to still hold the enforcement conference since WB's history with the Department and previous consultant has not been very promising. GC told me that WB won't be able to make the Aug 26 enforcement conference and was wondering if GC could come in his place. I said no. GC also inquired whether or not it is necessary for a lawyer to accompany WB at the enforcement conference. I said that is up to WB.

WB has not yet contacted me in writing or verbally to reschedule the enforcement conference. If he fails to notify the Department prior to Aug 26 and does not attend, his files will be transferred to our enforcement specialist and WB will be referred to the Dept of Justice, as outlined in the July 27 letter to WB.
