Dear Review Staff:

Enclosed please find a PECFA claim for the completion of the Site Investigation and proposed Remedial Action Plan. The total amount claimed is \$28,135.90. I have enclosed a disk that contains the claim worksheet put together by your department.

This claim is associated with a several gasoline USTs that were abandoned inplace prior to 1976. A heating oil UST was also removed prior to 1992. Laboratory costs associated with heating oil analyses (DRO & PAH) were separately invoiced and left out of this claim. Only low DRO concentrations were found in the soil and only naphthalene was found in the groundwater. Outside of laboratory costs, no additional work was required to investigate a release from the former heating oil UST. There are no future remediation activities associated with the former heating oil UST.

Because high levels of dry cleaning solvents (PCE) are also present within the soil and groundwater, project costs during the investigation have been split in half: PECFA 50% and Dry Cleaner Environmental Response Program (DERP) = 50%.

Our March 2002 Remedial Action Options Report (RAOR) did recommend actively remediating PCE contamination in the soil and groundwater. Our RAOR recommended not actively remediating the petroleum contamination at the site. We felt natural attenuation would be sufficient to remediate the petroleum groundwater plume. Future PECFA costs shall be limited to monitoring the groundwater plume. The anticipated PECFA costs to bring this site to closure shall not exceed \$60,000.
