Dear Mr. Orto:

On November 7, 2002, Scott Petlewski of Envirogen, Inc., notified the Wisconsin Department of Natural Resources (WDNR) that petroleum contamination had been detected at the site listed above. On December 27, 2004, a Notice of Contamination was applied to the property deed for the contamination found in the soil and groundwater.

On May 10, 2018 you received a letter, a copy is enclosed, as the current property owner indicating your responsibility for investigating and restoring the environment at the above-described site under Section 292.11, Wisconsin Statutes, known as the hazardous substances spills law. That letter directed you to hire an environmental consultant and submit a work plan for the investigation by July 9, 2018. To date, you have not taken any action to investigate the contamination remaining at the above-described site.

If you would like to remove the Notice of Contamination from your property, you will need to hire an environmental consultant and submit a site investigation work plan that aims to sample soil and groundwater in order to determine the degree and extent of petroleum contamination.

Within 30 days, by **November 26, 2020**, submit written verification indicating your intentions to move forward with the additional soil and groundwater investigation. Within 60 days, by **December 26, 2020**, submit written verification (such as a letter from the consultant) that you have hired an environmental consultant.

Additional Information

Sites where discharges to the environment have been reported are entered into the Bureau for Remediation and Redevelopment Tracking System (BRRTS), a version of which appears on the WDNR's Internet site.
