Dear Mr. Zeichert,

A bid deferment (using Usual & Customary schedule of charges)/variance is being submitted for safety/security at the subject property located at 2335 W. Atkinson Avenue in Milwaukee, Wisconsin. Based on previous site visits and an incident while working on-site we are requesting one of the two following options be approved for the excavation project. The options we are recommending are: [1] During the excavation project plan to remove all equipment from the site at the end of each day, place in a secure parking lot, and mob back to the site in the morning or [2] hire a security company for overnight protection of equipment from theft/vandalism. The costs for the two above options are as follows:

Option #1: Demob/mob off-site each day	\$2,100.00 (Variance)
Option #2: Security Company for overnight	\$ 560.00 (Variance)
Change Order Request	\$ 381.78

METCO is requesting a bid deferment/variance in the amount of **\$2,481.78 (Option #1)** or **\$941.78 (Option #2)** to complete the above activities. We would prefer Option #2 as it will also save some time at the beginning and end of each workday and is also the cheaper of the two options. Once the additional costs are approved, METCO will proceed with project (which is tentatively planned for early June).

Please note that if we determine additional security is warranted during working hours, we will contact you about having an armed guard on-site (\$35/hour) during the day.

Attached is a breakdown of costs for the above work scope as required.
