The work will include: [1] Primary Closure Request, [2] Continuing Obligations Packet Submittal (Source Property and up to one off-site property), [3] Professional Engineer review and certification of closure packet, and [4] Abandonment of all remaining site monitoring wells (6 total) if closure is approved.
