Dear Mr. Paulson:


The Department of Natural Resources (DNR) reviewed the additional information you submitted on May 14, 2019 regarding your material management plan. This information was provided in response to DNR's April 11, 2019 request for further details on how contaminated material within several stockpiles was characterized and how the stockpiled material will be reused at this site.

The DNR understands that site remediation is currently underway or will start in the near future and that material management activities are scheduled to continue throughout the next year. A significant effort is being made to monitor air emissions and control stormwater runoff to ensure these site activities are not a detriment to the surrounding area. However, if it becomes apparent that the reuse of the stockpiled material on this site will be delayed until after June 2020, the DNR recommends you consider taking additional actions to cover these stockpiles to prevent exposure.

Stockpiled material in Pile 39, Pile 59, the SE Pile, the SW Pile, the concrete fines pile, and the brick fines pile has been sufficiently characterized to allow the reuse of the material on-site. In general concurrence with DNR's April 11, 2019 letter, you stated that material from Pile 59 and the brick fines pile will not be reused within 30 feet of a structure. Also, material from Pile 39 and the concrete fines pile will be reused in the in-situ stabilization area or under an impermeable cap. As it was not specifically mentioned in your response, the DNR would again recommend that material from Pile 59 also be reused in the in-situ stabilization area or under an impermeable cap. The final deposition of the stockpiled material should be documented in a future report as you recommend. Identifying where contaminated material is reused on-site, and how site conditions after placement will prevent the contamination from posing a risk, will be a requirement for obtaining case close.
