Josh,

The DNR has reviewed the high purge volume sampling plan that you recently submitted and provides the following comment:

- The high purge volume sampling plan proposes to collect a standard sub-slab sample near HV-1 to validate the results of the high purge volume sample that will be collected from HV-1. The DNR recommends collecting standard sub-slab samples near at least 2 additional high purge sample locations to validate the results from additional locations. Also, it is unclear what criteria were used to select HV-1 as the location for the proposed standard sub-slab sample. The DNR recommends that the standard sub-slab samples are collected near the high-purge sample locations that have the highest potential for sub-slab impacts based on current soil and groundwater conditions at the site.
