On March 8, 2023, the DNR received the results of the sub-slab vapor sampling which was conducted at the Milwaukee Solvay/Komatsu site on February 8 and 9, 2023. The results were submitted with a cover page that concludes that the data shows that the risk for vapor intrusion of benzene and naphthalene are minimal. Initial comments regarding the results are provided below:

- The DNR notes that there is considerable variability between the high purge sample results and standard sub-slab results collected at certain locations including HV-3 and HV-7. An explanation of the variability observed should be provided.
- Naphthalene was identified at HV-7 at a concentration of 699 μg/m³ which exceeds the large commercial/industrial vapor risk screening level of 360 μg/m³. A plan to address this exceedance should be provided.
- Based on the May 2022 sampling plan, the DNR understands that an additional round of sampling is planned for a time of high groundwater conditions. When do you plan to conduct the additional sampling described in the May 2022 sampling plan?
- The sample results were submitted without a report that includes a description of the sampling methodology, discussion of results, data tables and figures, or conclusions and recommendations. A report that includes a discussion of results, data tables, recommendations etc. should be submitted.
