Eric said they were adding an additional 2' per well for five wells as there was ~4' of water in the first well. One of the borings got concrete refusal at 6' bgs and had to move. Also, because of the cold weather and having a hard time getting the drill rig started the work has gone into two extra days, thus we will need 2 additional consultant overnight per diems and 4 overnight per diems for the drill crew (2 additional nights for two crew members). Costs are as follows:
