Dear Mr. Ross:

EnviroForensics, LLC (EnviroForensics) is providing this Off-Site Access Status Update on behalf of the Former Packard Way Cleaners located at 3650-3652 East Barnard Avenue in Cudahy, Wisconsin (Site). In the past, the Wisconsin Department of Natural Resources (WDNR) had requested off-site vapor intrusion (VI) assessments and additional subsurface investigation. In order to perform the additional work, off-site access was needed.

This update summarizes the current standing of off-access and to request assistance in obtaining access to off-site properties. Except in the case of 3648 E. Barnard Ave. for vapor intrusion sampling, the WDNR was not specific where access was needed to clarify the groundwater plume. EnviroForensics was not able to gain access to the aforementioned location in addition to the following properties for groundwater delineation.

- 3651 E. Squire Avenue;
- 3663 E. Squire Avenue; and
- 3677 E. Squire Avenue.

Multiple letters have been mailed or hand delivered. Additionally, in person visits have been attempted during various times of the day. As shown on **Table 1**, at least three (3) attempts were made to gain access at each property and in the case of 3648 E. Barnard more than three (3) attempts were made. Therefore, EnviroForensics has made a best faith effort as defined in RR-800 to obtain access to perform site investigation activities.

If the WDNR feels the additional investigation activities are still needed at the off-site properties, we are requesting assistance from the WDNR to gain access to the above referenced properties. Property information can be found on **Table 1**.

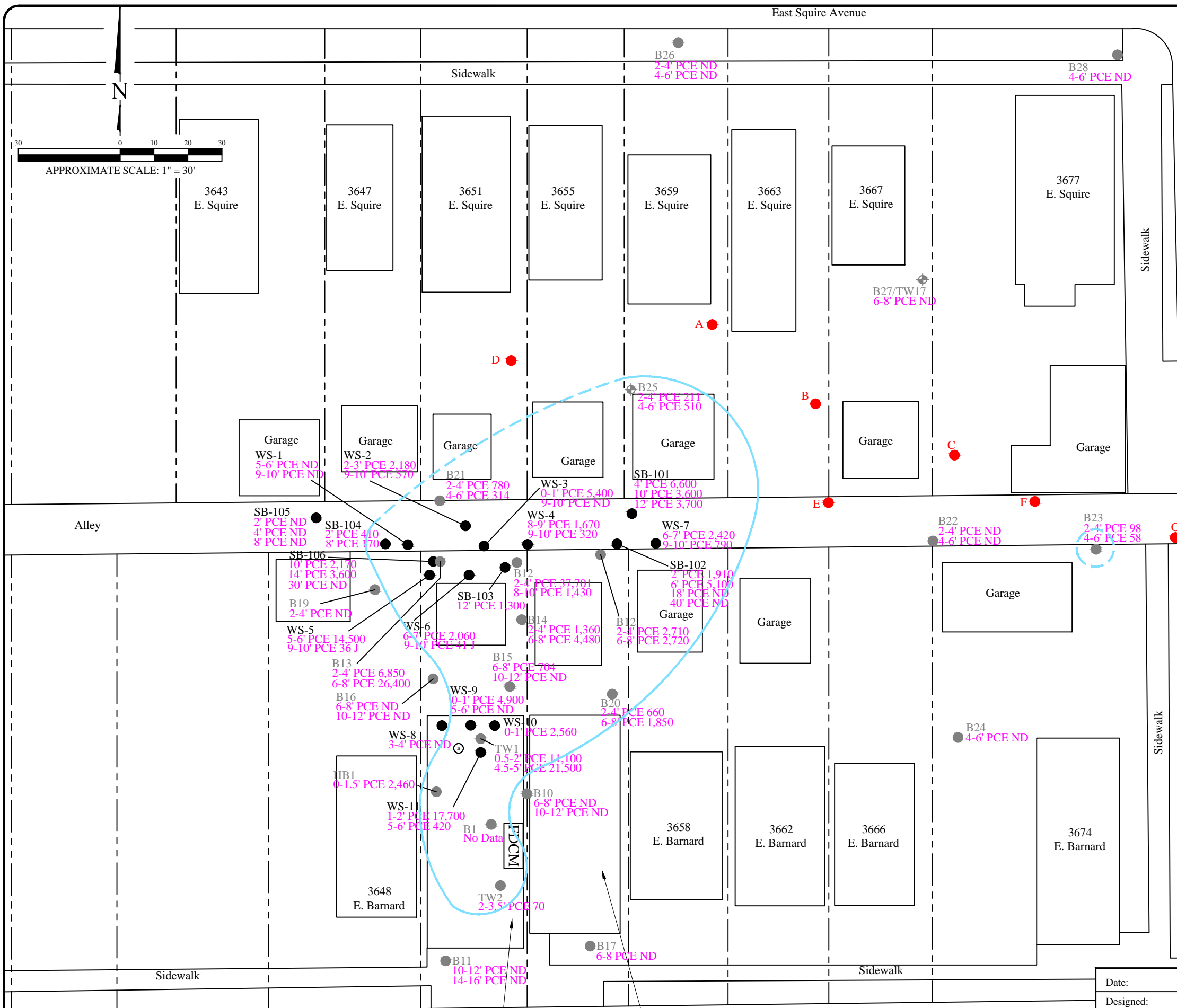

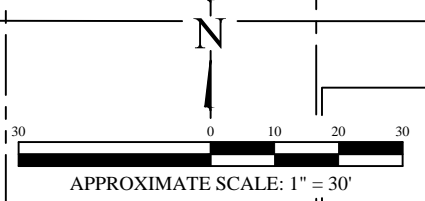
