Roy F. Weston, Inc. (WESTON®) has prepared the following list of soil background sampling locations on behalf of the settling defendant for the Moss-American Superfund Site, Kerr-McGee Chemical Corporation (KMCC). This letter summarizes the soil sampling locations that were discussed and agreed upon in our group meeting of 13 August 1992.

The background sampling locations for each habitat are described below, and are also identified in the enclosed Figure 1. The number and letter identifiers on Figure 1 correspond to the location descriptions provided below.

Nonforested Upland Habitat

- 1A. Little Menomonee River Parkway - Approximately 1/4 to 1/2 mile north of Brown Deer Road, east of the river, outside of the 100-year floodplain.
- 1B. Little Menomonee River Parkway - North of Fond du Lac Avenue, east of 98th Street, outside of the 100-year floodplain.
- 1C. Little Menomonee River Parkway - North of Appleton Avenue, east of 107th Street, outside of the 100-year floodplain.

Broad Leaf Deciduous Forest Wetland

- 2A. Menomonee River Parkway - North of Mill Road, south of Highway 175.
- 2B. Menomonee River Parkway - Approximately 3/4 mile upstream of confluence with Little Menomonee River.
- 2C. Menomonee River Parkway - North of Highway 175, south of Good Hope Road.
- 2D. Menomonee River Parkway - North of Good Hope Road, south of Highway 45.

Broad Leaf Deciduous Scrub/Shrub Wetland

- 3A. Little Menomonee River Parkway - Approximately 1/4 mile north of Brown Deer Road, east of the river.
- 3B. Menomonee River Parkway - Approximately 3/4 mile upstream of confluence with Little Menomonee River.
- 3C. Menomonee River Parkway - North of Good Hope Road, south of Highway 45.
- 3D. Menomonee River Parkway - North of Highway 175, south of Good Hope Road.

Reference should also be made to our letter of 30 March 1992 that defined sampling locations for background sediment, upstream of the former wood preserving facility.

Background sampling for soil and sediment will be performed in accordance with the field sampling plan and is proposed to be conducted prior to 31 October 1992, pending U.S. EPA approval of the Interim QAPP. WESTON and KMCC will notify U.S. EPA and WDNR of the exact dates for this activity as soon as the scheduling is arranged.

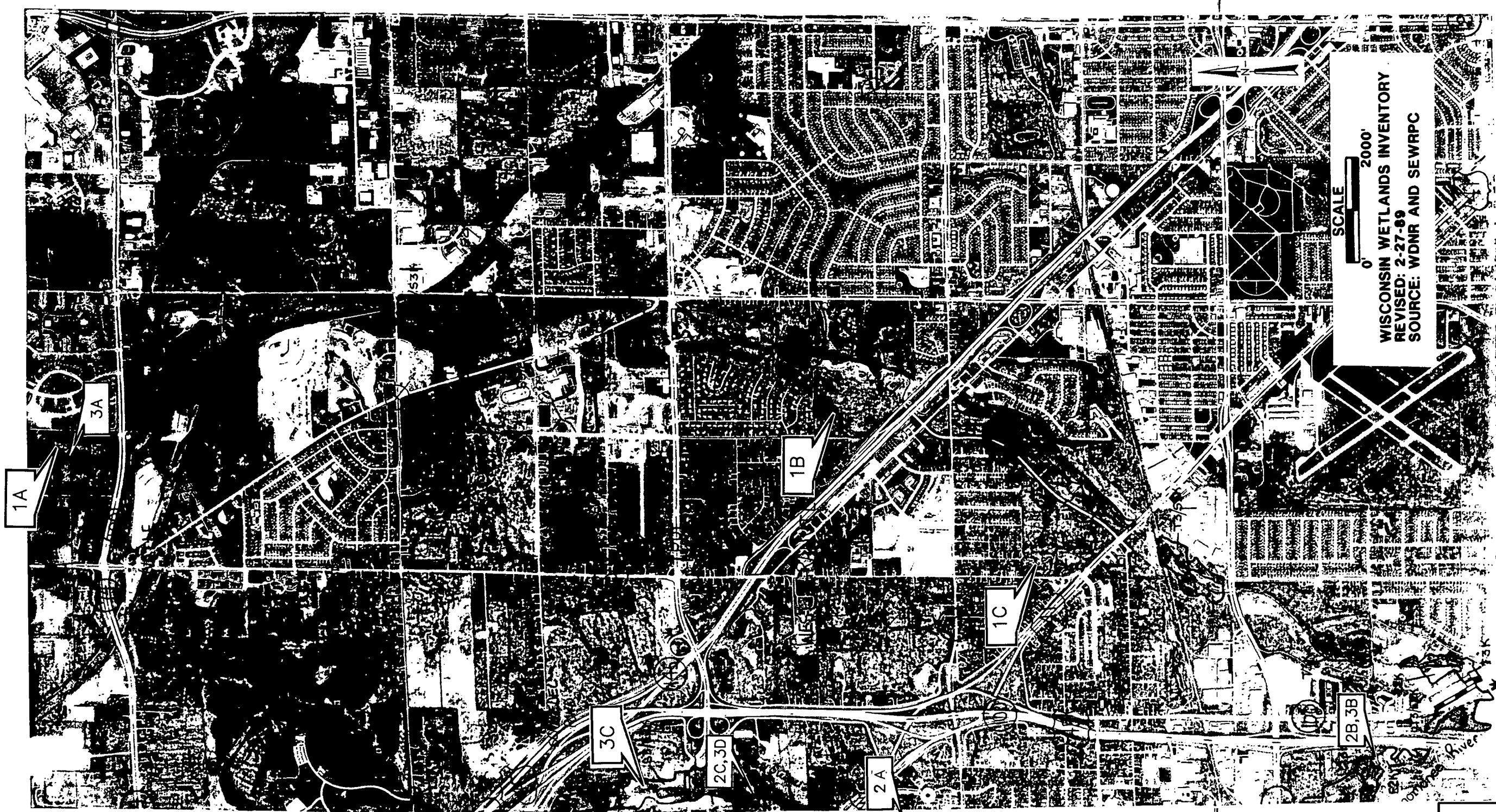

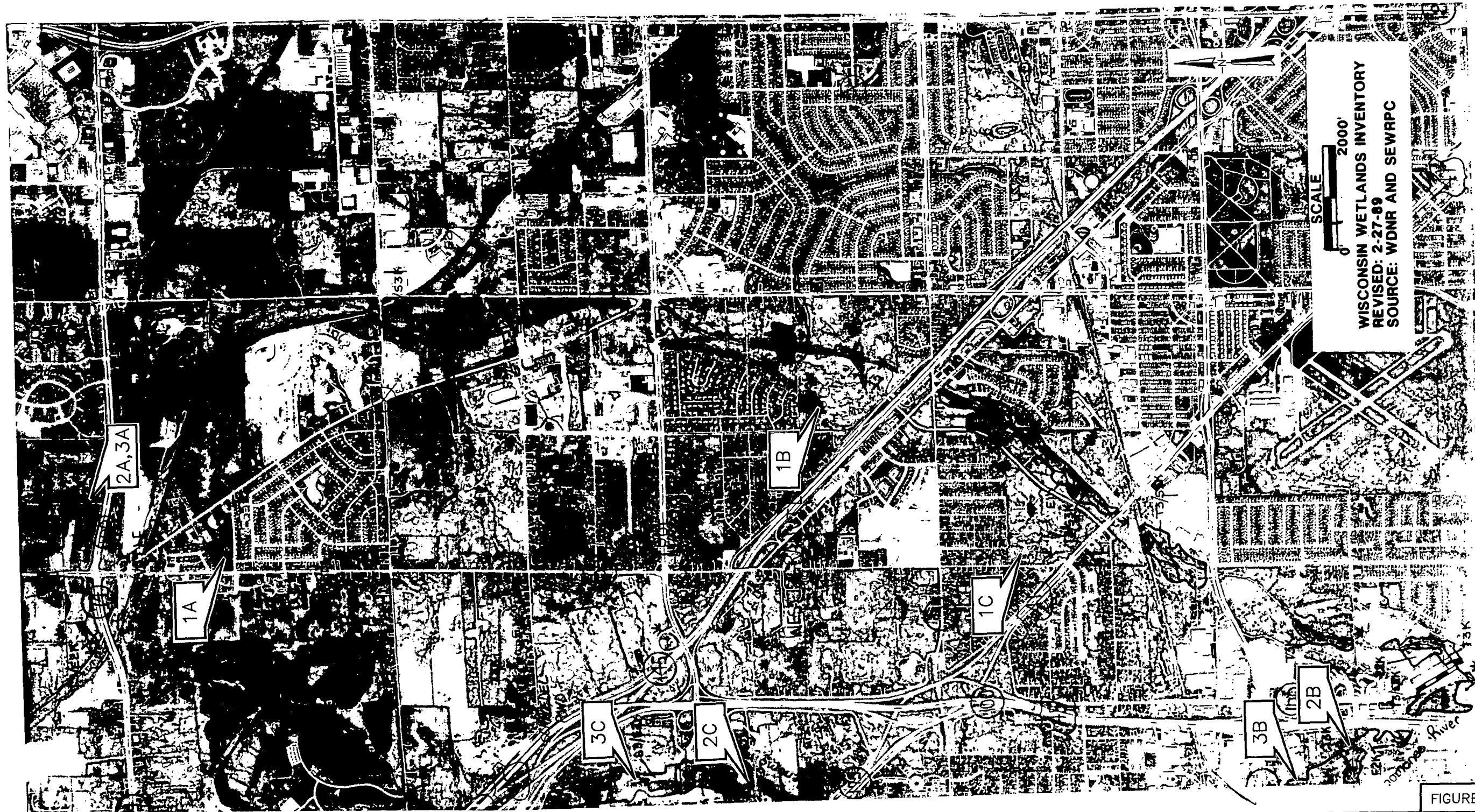
