

Roy F. Weston, Inc. (WESTON®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical Corporation (KMCC). This monthly progress report has been prepared to document progress during February 1995.

## Progress During February 1995

As was reported in January's progress report, KMCC and WESTON have continued progress in preparing design and construction plans for a free-product recovery and removal system at the Moss-American site. KMCC is working toward a schedule of installing the recovery system components and implementing free-product removal during the summer of 1995. We anticipate transmitting a draft free-product system design for U.S. EPA review in March 1995.

Also during this reporting period, KMCC and WESTON have begun to prepare clarifying information and responses to several project correspondences that were transmitted during January including:

- On 23 January 1995, U.S. EPA transmitted comments prepared by CH2M HILL on the November 1994 Predesign Technical Memorandum.
- On 1 February 1995, Wisconsin DNR issued review comments to U.S. EPA on the November 1994 Predesign Technical Memorandum. WESTON and KMCC were copied on this correspondence to U.S. EPA.
- On 8 February 1995, U.S. EPA provided a response to WESTON's proposed 1995 design/predesign work schedule, as outlined in WESTON's letter dated 17 January 1995.

## Activities Anticipated During March 1995

During March, KMCC and WESTON will complete work on the draft design of a free-product recovery and removal system. These efforts will continue as we work with U.S. EPA to have a free-product removal system operational at the site during the summer of 1995. During March, we also anticipate completing responses to U.S. EPA, CH2M HILL, and WDNR comments on the findings and recommendations of our 21 November 1994 Technical Memoranda submittals.
