

Roy F. Weston, Inc. (WESTON®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical Corporation (KMCC). This monthly progress report has been prepared to document progress during July 1996.

Progress During July 1996

During this period, KMCC/WESTON conducted the following:

- We prepared a written summary of a potential interim soil remediation approach, in response to U.S. EPA's request. This transmittal was dated 10 July 1996.
- We continued the operation of the free-product recovery system at the site.
- We remobilized contractors for investigative waste drum management and additional fence installation at the site. Drum overpacking and management is complete. The new fence installation is approximately 70% complete.
- We continued to implement work on the 60% remedial design (RD) for the groundwater remedial system.

Activities Anticipated During August 1996

During August, KMCC/WESTON anticipate the following activities:

• We anticipate submittal of the 60% RD for the groundwater remedial system.
