Progress During September 1998

Progress during this reporting period includes:

- KMC/WESTON submitted the 2nd quarter groundwater monitoring report to the Agencies on 10 September 1998.
- KMC/WESTON submitted a letter to the Agencies on 16 September 1998 discussing relocation of the temporary storage pad.
- KMC/WESTON completed the 3rd quarter groundwater monitoring during the week of 28 September 1998.

Activities Anticipated During October 1998

During October, KMC/WESTON anticipate the following activities:

- KMC/WESTON are completing preparations for the installation of the temporary storage pad at the site. Installation will occur in October/November 1998.
- KMC/WESTON await further developments and details from the land trustees regarding a possible expansion of the river remediation/restoration scope.
