Progress During July 1999

Progress during this reporting period includes:

- The QAPP for installation of the groundwater remedial system was submitted to the Agencies on 9 July 1999. KMC/WESTON have received comments on the QAPP from the Agencies.
- The Notice of Intent to discharge treated water to the Milwaukee Metropolitan Sewerage District was approved in a letter dated 20 July 1999.

Activities Anticipated During August 1999

During August, KMC/WESTON anticipate the following activities:

- The following documents are being prepared for submittal to the Agencies:
 - Response to Agency Comments on the Pilot Scale Study for River Remedy.
 - Response to Agency Comments on the QAPP for installation of the groundwater remedial system.
 - □ NR 103 Alternative Analysis for wetland impacts on the former wood-treating facility.
