Weston Solutions, Inc. (WESTON®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical LLC (KMC). This monthly progress report has been prepared to document progress during March 2003.

Progress During March 2003

Progress during this reporting period includes:

- KMC worked to schedule a meeting with U.S. EPA/WDNR to resolve issues related
 to restoration design of the river remedy. It now appears that a meeting will occur in
 the first half of April.
- The Q1 2003 groundwater monitoring event was performed during the week of 3 March.

Activities Anticipated During April 2003

During April KMC/Weston anticipate the following activities:

- KMC/WESTON will meet with U.S. EPA/WDNR to discuss and resolve restoration issues affecting Reach 1 and the resumption of design for Reaches 2/3.
- Information collected during the first phase of the hydrogeologic investigation was analyzed, the groundwater flow model was constructed and calibrated, and is now undergoing internal review.
- KMC/WESTON will prepare a report summarizing recent data collected on CPAH levels in Little Menomonee River tributaries.
- The Q1 2003 groundwater monitoring report will be prepared.
