Weston Solutions, Inc. (WESTON®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical LLC (KMC). This monthly progress report has been prepared to document progress during October 2003.

Progress During October 2003

Progress during this reporting period includes:

- KMC/WESTON/Inter-Fluve met with U.S. EPA/WDNR representatives on 21 October to submit and discuss the Prefinal Design Report for Reaches 2 and 3.
- On 24 October KMC/WESTON provided a letter report addressing temporary floodplain storage of clean soils and revised locations of silt fencing. These issues were raised during the 21 October meeting and WDNR requested additional supporting documentation.

Activities Anticipated During November 2003

During November KMC/WESTON anticipate the following activities:

- KMC/WESTON/Inter-Fluve will respond to any comments received from the Agencies on the Prefinal Design Report and begin preparation of the Final Design Report.
- KMC/WESTON will conduct annual inspections of Reach 1 and provide the results to U.S. EPA/WDNR in a Monitoring Report.

- WDNR has informed KMC that the Agency will provide a letter documenting its
 position on soil/sediment waste classification. Upon receipt, KMC will review the
 document and respond as appropriate.
- The feasibility and efficacy of potential modifications to the groundwater treatment system are currently under review.
- KMC/WESTON will continue preparation of a report summarizing recent data collected on CPAH levels in Little Menomonee River tributaries.
