Weston Solutions, Inc. (Weston®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical LLC (KMC). This monthly progress report has been prepared to document progress during December 2003.

Progress During December 2003

Progress during this reporting period includes:

- On 3 December KMC/WESTON participated in a conference call with WDNR to further clarify issues regarding waste classification for impacted sediment and soils. KMC awaits a WDNR communication on this topic.
- The Q4 groundwater monitoring event was conducted during the week of 8 December.
- North Star Environmental removed additional sections of haul road in Reach 1 that were deemed to be no longer needed.
- On 29 December KMC/WESTON/Inter-Fluve provided U.S. EPA and WDNR with draft responses to Agency comments on the Prefinal Design Report for Reaches 2 and 3.

Activities Anticipated During January 2004

During January KMC/Weston anticipate the following activities:

After receiving notification of the adequacy of the draft responses to Agency comments, KMC/WESTON/Inter-Fluve will finalize the comment responses and then prepare the Final Design Report for Reaches 2 and 3.

- KMC/WESTON will submit a monitoring report for Reach 1.
- KMC will submit a report discussing the ROD remedy for Reaches 4 and 5.
- The feasibility and efficacy of potential modifications to the groundwater treatment system are currently under review.
- KMC/WESTON will continue preparation of a report summarizing recent data collected on CPAH levels in Little Menomonee River tributaries.
