Weston Solutions, Inc. (Weston®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical LLC (KMC). This monthly progress report has been prepared to document progress during February 2004.

Progress During February 2004

Progress during this reporting period includes:

- On 13 February 2004 KM/Weston submitted to the Agencies the Final Design Report for Reaches 2 and 3 remediation.
- KM received a letter dated 25 February 2004 from U.S. EPA indicating design approval for Reaches 2 and 3 remedial action.
- In late February KM received notification from WDNR that it would not object to management of excavated sediment by disposal at PDC. Loading and hauling of stockpiled sediment will begin near the end of March.

Activities Anticipated During March 2004

During March KMC/Weston anticipates the following activities:

• A kickoff meeting for the construction activities in Reaches 2 and 3 was held on 1 March in Milwaukee, WI at the site trailer. Representatives of the following stakeholders were present: U.S. EPA and its oversight contractors (CH2M Hill, TN& Associates), WDNR, Milwaukee County Parks, Kerr-McGee, Weston, Inter-Fluve, and North Star Environmental. The first phase of construction (excavation and restoration of new river channel sections) is expected to be completed by the end of May 2004.

- Construction activities in March will include: clearing and grubbing, snake and construction fence installation, haul road construction, culvert installation, and channel excavation.
- The Q4 2003 groundwater monitoring report will be submitted.
- The Q1 2004 groundwater monitoring event will be performed during the week of 15 March.
- KMC/Weston will submit a monitoring report for Reach 1.
