Weston Solutions, Inc. (Weston®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Kerr-McGee Chemical LLC (KMC). This monthly progress report has been prepared to document progress during April 2004.

## **Progress During April 2004**

Progress during this reporting period includes:

- Considerable progress was made during April on the Reach 2/3 new channel construction. Clearing and grubbing in Reaches 2 and 3 was completed, along with snake fence, silt fence and construction fence installation. New channel construction and restoration activities were nearly completed in Reach 2 between Bradley Road and Calumet Road.
- Transport of Reach 1 excavated sediment to PDC was completed on 20 April. Shipments totaled 292 truckloads (7150 tons) in April.
- The annual report to the Court, as required under the CD, was submitted on 21 April.

## Activities Anticipated During May 2004

During May KMC/Weston anticipates the following activities:

- Construction activities in May will include: new channel excavation and restoration activities in the remainder of Reach 2 and Reach 3. This phase of work is expected to be completed in early June 2004.
- The Q1 2004 groundwater monitoring report will be prepared.
