Progress During February 2005

Progress during this reporting period includes:

- KMC has communicated with U.S. EPA and WDNR project managers regarding a meeting to discuss a mutually-agreeable path forward on Reaches 4 and 5. It is our hope that a meeting can be set for some date in March 2005
- On 4 February KMC submitted a report to the Agencies documenting the sediment disposal for LMR Reaches 2 and 3.
- After receipt of final survey data, KMC has directed Weston to update the LMR flood models for as-built conditions in Reaches 2 and 3.

## Activities Anticipated During March 2005

During March KMC/Weston anticipate the following activities:

- KMC will submit a report to the Agencies documenting the progress of re-vegetation in Reach 1.
- The Q4 2004 groundwater monitoring report will be submitted to the Agencies.
