Weston Solutions, Inc. (WESTON®) has prepared this monthly progress report on behalf of the Settling Defendant for the Moss-American Superfund site, Tronox LLC (Tronox), formerly Kerr-McGee Chemical LLC. This monthly progress report has been prepared to document progress during May 2007.

Progress During May 2007

Progress during this reporting period includes:

- On 9 May Tronox participated with the Agencies on a conference call to continue discussions of Reach 4/5 river remediation. As a result of the discussion, Tronox agreed to prepare a proposal for river remediation and submit it to the Agencies.
- On 23 May Tronox issued its proposal for Reach 4/5 river remediation to the Agencies.
- Tronox has contracted with Gary Casper to provide support in 2007 for the assessment of Butler's garter snake issues in the project area. Mr. Casper has already begun assessment work in Reach 4/5, and has also begun work required under takings authorizations to assess the snake's utilization of areas in Reach 1, 2, 2, and 4A that we previously remediated.

Activities Anticipated During June 2007

During June Tronox anticipates the following activities:

 Tronox will prepare a report documenting the Reach 4 /5 sediment sampling performed in December 2006. Mr. Russell D. Hart U.S. EPA
