Dear Ms. Mylotta:

It was a pleasure meeting with your staff on Thursday, October 27, 2016 to discuss the WDNR's Case Closure Denial – Site Investigation Incomplete, correspondence dated August 10, 2016. As we indicated during our meeting, D&C Partners, LLP (D&C Partners) recently retained St. John – Mittelhauser & Associates, Inc. (SMA) to perform consulting services, site monitoring, reporting and any necessary environmental testing at the above referenced Site in an effort to obtain environmental closure of the Site through the WDNR.

SMA is currently reviewing the file and developing our response to WDNR's August 10, 2016 correspondence. Given the complexity of the Site, SMA and D&C Partners request the WDNR grant an extension until December 31, 2016 to finalize our response. Our response will include:

- Submission of a work plan to the WDNR outlining the proposed Site investigation activities to delineate the lateral and vertical extent of the contaminants of concern in the soil and groundwater;
- Upon performing inspection, documentation and labeling of the vapor mitigation system, we will submit revisions of a finalized maintenance plan for the vapor mitigation system; and
- Verify that proper notification regarding the January 2016 offsite investigation has been completed to both the Union Pacific Railroad and the WDNR.

In addition to the three items above, SMA and D&C Partners will:

- Upon completion of Site Investigation activities, submit a Site Investigation Report in accordance with NR 716.15 to the WDNR for review and approval. Once the WDNR concurs that the site investigation is complete, a Remedial Action Option Report will be drafted outlining the selected remedial action for the Site;
- Review the analytical data collected at the Site and segregate wastes that could be considered hazardous. All wastes will then be fully characterized, documented, and disposed of accordingly; and
- Provide the WDNR with status updates on a semi-annual basis.
