## **NOTICE OF VIOLATION**

The Department of Natural Resources has reason to believe that you are in violation of hazardous substance release requirements on the property you own at 2346 W. St. Paul Avenue in the City of Waukesha.

S. 292.11(3), Wis. Stats., states "Hazardous substance spills. (3) Responsibility. A person who possesses or controls a hazardous substance which is discharged or who causes the discharge of a hazardous substance shall take the actions necessary to restore the environment to the extent practicable and minimize the harmful effects from the discharge to the air, lands or waters of this state."

The analytical results of groundwater monitoring were submitted by RSV Engineering on behalf of Klinke Cleaners on March 21, 2006. These results indicate concentrations of tetrachloroethene above the NR 140 enforcement standards in wells 3, 5 and 8. The enforcement standard for tetrachloroethene is 5 parts per billion (ppb). Well #3 had a concentration of 64,000 ppb in March, 2005. High levels of tetrachloroethene have also been found in soil samples on the property.

To assist in determining the degree and extent of contamination, it is necessary for you to install off site wells. To the best of our knowledge, you have not secured the necessary permission from Cooper Power Systems, Inc. to install groundwater monitoring wells and to conduct quarterly monitoring.

Brenda Boyce, DNR-Hydrogeologist, has been attempting to facilitate an agreement between Cooper and Klinke since October, 2006 but has not met with success. There is a high degree of risk associated with tetrachloroethene because of the presence of a public water supply well within 500 feet of the contaminant plume.
