Per the EPA TSCA approval and the regulations cited therein at 761.61(a)(5)(i)(B)(2)(iii), > 50 ppm wastes can go to a hazardous waste landfill permitted under RCRA. I know Heritage's permit has conditions allowing them to accept PCB Remediation Waste under certain TSCA Approvals.
