Hi Tauren – I'm working with Gabe Rodriguez on the Mirro 9 site in Manitowoc and am writing to provide a status update on Newell's work plan for the Site. I know you previously spoke with Newell's consultant Jeanne Tarvin of Ramboll regarding a proposed work plan. Since then, we have come to an agreement with the City on the terms of Newell's access to the Site to conduct investigation activities.

However, we learned Friday that the City conducted additional work at the Site that likely affects Newell's proposed work plan.
