Stantec, on behalf of the City of Manitowoc, has submitted a report (titled Phase II Environmental Site Assessment, dated March 19, 2020) which includes more PCB data and a fee is being submitted this Friday for DNR to review the site investigation at this site. Other DNR staff and myself will be looking at the site investigation data and will be providing a written response to the City & Stantec on additional site investigation that is needed. Based on our previous discussions with the coordinated approval process, I don't think you need to provide any coordinated approvals on your end until an official RAOR is submitted for remediation of the PCB contamination. Is that correct?

I wanted to provide you with the report though because it is quite a comprehensive report and does include some information about how they are thinking of planning to remediate the PCBs in Sections 5

and 6.
