Good morning Jeanne,

The PFAS Groundwater Investigation Work Plan was received on July 17, 2020 and the fee for review was received on August 3, 2020. The work plan has been reviewed and the DNR has determined that the plan needs to be revised and resubmitted with the following additions:

- Newell needs to coordinate with the City of Manitowoc Public Works to sample the municipal well closest to the site for PFAS.
- Additional monitoring well installation and sampling for PFAS in groundwater surrounding the site to the west, north, and east of the site needs to be proposed at this time.

This work plan only pertains to PFAS in groundwater. It is the responsibility of a RP to evaluate hazardous substance discharges and environmental pollution, including emerging contaminants, under the Wis. Admin. Code NR 700 rule series. Per Wis. Admin. Code § NR 716.07 and Wis. Admin. Code § NR 716.09, site investigation scoping and work plans should include an evaluation of all potential or known contaminants in all applicable environmental media. Therefore, PFAS and other contaminants in all potentially or known impacted environmental media need to be further investigated to complete the site investigation. A Site Investigation Review letter will be provided as a separate response to the City of Manitowoc's request for a review of the site investigation received by the DNR on July 16, 2020.

Once a revised work plan has been submitted that includes the above additions, a letter response will be provided by the DNR for approval of the plan.
